1. Introduction

2. Personal Data We Collect

6. Data Retention

Your personal data will be retained for as long as necessary to fulfil the purposes for which it was collected, and to comply with applicable legal and regulatory requirements.

7. Your Rights

You have the following rights concerning your personal data:

- Access: Request access to your personal data held by us.
- Correction: Request correction of inaccurate or incomplete personal data.
- Withdrawal of Consent: Withdraw your consent for processing your personal data where applicable.
- Objection: Object to the processing of your personal data for specific purposes.
